TASTER LESSONS AND STARTER PACKAGES

There are very few things that compare to the thrill of taking control of an aircraft for the very first time. Following a pre-flight briefing from your instructor and discussion on the suggested route to be flown, you will be taken to your allocated aeroplane and shown the pre-flight inspection.

Following pre-flight checks, you will shortly be taxiing to the threshold ... full power ... brakes off ... speed reached ... rotate ... leaving runway behind you, you will be airborne.

Your instructor will tell you that 'You have control' and YOU will be flying the aeroplane ... A one-off experience or the start of an exciting adventure to achieve a Private Pilot's Licence or to explore a career in aviation ... the choice is yours ... the sky is the limit!

TERMS AND CONDITIONS

Availability and Booking your Lesson – All lessons must be booked in advance subject to availability. In order to avoid disappointment we recommend customers book well in advance and do not arrange transport until the booking has been confirmed by Air First Ltd. Please ensure that adequate time is allowed in order to book your lesson. Weekend days are the busiest times and therefore a longer period of notice may be required to satisfy a specific time, day or date. Please allow up to 3 weeks notice for a weekend slot. You should be aware that flying is highly weather dependent. If unlucky with the weather, you may need to book a couple of times so **you are advised NOT to wait until the 5th or 6th month before using your voucher!** If a specific time/day is not important to you and the weather looks fine an 'On the Day' booking may be possible – phone and ask!

You will need to bring 2 forms of identification with you when you come for your lesson. This should be one photographic (passport, driving license) and a proof of address (telephone, water, gas, electricity). Please speak to Operations if you are unable to supply an appropriate means of identification.

Please do not arrive at the venue expecting to redeem your gift voucher without first obtaining confirmation of availability, on the actual day, from Air First Ltd on 01252 870999 It is important to follow the procedure set out in these terms and conditions as Air First Ltd WILL NOT be held liable for any costs, including travel, incurred.

Please arrive in good time for your lesson/s. If you have a Trial Lesson 10 – 15 minutes early will be sufficient for paperwork. If you have a Starter Package you will be required to arrive a little earlier to allow for pre-flights checks and preparation. If you are late your lesson may be shortened or cancelled.

Everyone that flies from our school must be a valid member. Membership is included free for the duration of an introductory flight or 6 months, whichever is the earlier.

Validity – Each gift voucher is **VALID FOR A MAXIMUM OF 6 MONTHS** unless otherwise stated. A voucher will be deemed invalid if it is out of date (the validity is clearly stated on the gift voucher). If the customer or recipient is unable to utilise the voucher before the expiry date, an extension may be requested for which a revalidation fee of £48 (inc VAT) will be charged. If the price of a Trial Lesson has increased, the difference between the new and the original cost will also need to be paid. Providing the request for an extension is made to Air First Ltd prior to the original expiry date, an extension of 3 months (only one extension per Air First voucher) will be issued. Vouchers can only be extended if they are still inside their expiry date. **The voucher must be booked and FLOWN OR EXTENDED, BEFORE THE ORIGINAL EXPIRY DATE.** Air First Ltd recommends that all experiences are booked as early as possible. Additionally, extension to Membership will be required for the Flying Start Packages

Restrictions – Many of the gift vouchers offered have some type of restriction applied to them, for health and safety reasons, these restrictions are decided by Air First Ltd and include age, health, physical and size.

Please read all the information provided for each experience, it is your responsibility to ensure that you purchase a gift voucher appropriate for the intended recipient and it is the responsibility of the recipient to double check that the restrictions are not prohibitive. We are not responsible for any unsuitable vouchers being purchased and these restrictions being breached. If you are unsure of the suitability of the services provided, please call us on 01252 870999 with your query and we will advise you accordingly.

Cancellations - Please give as much notice as possible if you need to cancel a booking. A minimum 24 hours' notice is required to cancel a booking without incurring a cancellation fee of £80 (inc VAT). If a cancellation fee is incurred it will be charged to the account and will need to be paid prior to any subsequent flight.

Cancellations must be made via phone (01252 870999) between 09:00-17:00. **PLEASE NOTE: EMAIL CANCELLATIONS WILL NOT BE ACCEPTED.**

Turn off your mobile phone before you get in to the aeroplane.

Operators and Liability – When purchasing or redeeming Air First Ltd Trial Lesson or Flying Start vouchers, you acknowledge that the activity is highly dependent on certain factors beyond the control of Air First Ltd and agree that Air First Ltd is not liable for the cancellation, postponement, or alteration of any flight due to causes beyond its reasonable control including weather, medical or technical issues.

Spectators/Customers – We welcome spectators. Customers and spectators are expected to adhere to the rules and regulations of both the airport and AirFirst. If they are deemed under the influence of drugs or alcohol will not be permitted on site.

Refunds/Exchanges – All vouchers or funds allocated to any account are **NON-REFUNDABLE**. Vouchers cannot be exchanged but can be upgraded.

Gift Vouchers – All vouchers purchased can either be dispatched via royal mail or collected from the school. We do not send any vouchers via special delivery. We cannot be held liable for any loss suffered from mail being delayed. The gift voucher is invalid if it has been tampered with or defaced. Air First Ltd holds no responsibility for lost or stolen vouchers, please keep gift vouchers in a safe place and protect them as you would money. Replacements will not be issued.
