TOP UP TEN - BUILDER PLAN - PAY as YOU FLY

GENERAL TERMS & CONDITIONS relevant to all packages, vouchers and "PAY AS YOU FLY"

- **MEMBERSHIP IS MANDATORY AND MEMBERS ARE BOUND TO THE RULES IN THE FLYING ORDER BOOK**
- **FUNDS ON ACCOUNT ARE NON-REFUNDABLE.**
- **FLYING TRAINING, GROUND SCHOOL, ETC MAY ONLY BE CONDUCTED WHILST CUSTOMERS' ACCOUNTS REMAIN IN CREDIT. OUTSTANDING INVOICES MUST BE SETTLED ON LANDING.**
- The stated training hours at achieve either a LAPL (30 hours) or PPL (45 hours) are the **MINIMUM** number of hours required by the CAA before a skills test can be booked. HOWEVER, with many contributing factors, progress differs significantly from person to person. AirFirst cannot be held responsible for the number of hours taken to reach first solo, qualifying cross country and or Skills Test.
- Deposited funds for discounted vouchers/packages may not be used in conjunction with any other discounts offered by AirFirst Ltd.
- If the Member is under 18 years of age, that member's parent or guardian shall countersign these terms and conditions and in so doing, not only agrees to the terms but is also liable for payment of any money due to Air First Ltd.
- Hourly Rates, Packages, Fuel etc are correct and inclusive as at 1st February, 2018. They are not, however, exempt from any price changes/surcharges. If this occurs, the total hours expected from a package will ultimately be affected.
- Ground School/Briefing exceeding 15 minutes WILL BE invoiced at the hourly rate.
- Members undertake to call AirFirst to confirm conditions for the flight and arrive in time for the necessary checks and preparations, in readiness for their allocated timeslot. Failure to comply may result in shortened or cancelled lesson.
- CFI and/or FI may make the final decision on the suitability of the weather.
- **Air First Ltd operates a 24 hour CANCELLATION POLICY for EACH slot booked. CANCELLATIONS MUST BE MADE BY PHONE**

LAPL/PPL BUILDER PLAN (additional terms to the "General Terms and Conditions")

- The initial £500 deposit is held on member's account by AirFirst until the Builder Plan is completed according to the Terms and Conditions.
 - The deposit is non-refundable and may not be used for flying until the pre-agreed 8(LAPL) or 12(PPL) standing orders are complete.
 - In the event of member's failure to comply to the plan's timescales and payment schedule, AirFirst will recover any landings and discounts which have been applied, initially from the deposit. Any further money owed to Air First will be deducted from the flying funds on account and in cases where funds are not sufficient an invoice will be issued for immediate payment.
- When flying funds drop to the £500 deposit, flying may continue on a 'Pay As You Fly' basis, until the next 50 has been processed.
- Theory Exams will be charged at the discounted rate for the first attempt of each exam. Thereafter, they will revert to the full cost.
- To enjoy package benefits each and every payment must be paid on the 1st day of each month and before your account drops to the £500 deposit. Additionally, all 12 of the minimum payments must be paid within the pre-agreed **EIGHT (LAPL) or TWELVE (PPL) MONTHS**. Money left on account at the end of this time, can enjoy the package benefits for a further three months. Thereafter, full rates will apply.
- For EARLY TERMINATION of plan, **THREE MONTH** notice is required. Discounts/landings will be reclaimed and thereafter, any money on account may be used on a 'Pay as you Fly' basis for a period of three months ONLY.
- In the event of late payments or failing to complete the minimum term, **ANY DISCOUNTS APPLIED WILL BE RECLAIMED BY AIR FIRST AS DESCRIBED ABOVE IN THE EVENT OF INSUFFICIENT FUNDS THE SIGNATORY OF THIS AGREEMENT AGREES TO CLEAR OUTSTANDING INVOICES.**
