## **BUILDER PLAN** "additional terms to the "General Terms and Conditions"

### **• IN ADDITION TO THE GENERAL TERMS & CONDITIONS OF AIR FIRST, THE FOLLOWING WILL APPLY**

- The initial £500 deposit is held on member's account by Air First until the Builder Plan is completed according to the Terms and Conditions.
  - The deposit is non-refundable and may not be used for flying until the pre-agreed standing orders are complete (LAPL x 10 and PPL x 10).
  - In the event of member's failure to comply to the plan's timescales and payment schedule, Air First will recover any landings and discounts which have been applied, initially from the deposit. Any further money owed to Air First will be deducted from the flying funds on account and in cases where funds are not sufficient an invoice will be issued for immediate payment.
- When flying funds drop to the £500 deposit, flying may continue on a 'Pay As You Fly' basis, until the next S/O has been processed.
- Theory Exams will be charged at the discounted rate for the first attempt of each exam. Thereafter, they will revert to the full cost.
- To enjoy package benefits every payment must be paid on the 1<sup>st</sup> day of each month and before your account drops to the £500 deposit. Additionally, of the minimum payments must be paid within the pre-agreed time. Money left on account at the end of this time, can enjoy the package benefits for a further three months. Thereafter, full rates will apply.
- For EARLY TERMINATION of plan, **THREE MONTH** notice is required. Discounts/landings will be reclaimed and thereafter, any money on account may be used on a 'Pay as you Fly' basis for a period of three months ONLY.
- In the event of late payments or failing to complete the minimum term, in addition to a £25 Administration Charge, any discounts applied will be reclaimed by Air First as described above and in the event of insufficient funds the signatory of this agreement agrees to clear outstanding invoices.

## **TOP UP TEN** additional terms to the "General Terms and Conditions"

- Package Benefits may be enjoyed for a period of **SIX MONTHS** commencing from purchase date of package.
- To qualify for the package discounts, ALL 10 hours must be flown within **SIX MONTHS** of date of purchase of the package. Failure to comply will result in ALL discounts being disallowed and reclaimed from funds.

## GENERAL TERMS & CONDITIONS

The lesson time is calculated "BLOCKS TO BLOCKS" and may be subject to variance due to weather, traffic and Air Traffic requests. In addition to the obligatory Ground School (i. Preparation for Flight, ii. Introduction to the Circuit and iii. Introduction to Navigation) briefings exceeding 15 minutes WILL BE invoiced at £45 per hour. Hourly Rates, Packages, Fuel etc are correct as at 1<sup>st</sup> June 2021 but are not exempt from price changes/surcharges. Fuel surcharge will be applied if Avgas-100LL is increased to £1.40 (exc VAT).

**MEMBERSHIP IS MANDATORY AND MEMBERS ARE BOUND TO THE RULES IN THE FLYING ORDER BOOK** If the Member is a minor, the parent or guardian shall countersign the terms and conditions and in so doing, not only agrees to the terms but is also liable for payment of any money due to Air First Ltd. Platinum Members and At Cost Self-Fly Members undertake a TWELVE MONTH minimum contract (+ 3 months notice) to pay the published standing order rate. Should the member fail to comply with the payment schedule or request an early termination, in addition to a £25 Administration Charge and three months subscription in lieu of notice, Air First will invoice the member to recover any landings and discounts applied for the membership period. This will become payable on invoice date. The free 10<sup>th</sup> weekday hour, offered to Platinum Members, is the 10<sup>th</sup> hour of 9 paid hours (ferry flights do not qualify). The Excess Waiver is a minimum of 12 months contract, early termination is not possible.

**NON-REFUNDABLE POLICY** Vouchers or funds allocated to any account are **NON-REFUNDABLE**. Vouchers cannot be exchanged but can be upgraded (upgrade rate + £25 Admin Charge). A voucher may also be transferred (£25 admin charge).

**EXPIRY DATES** Check and note the expiry date on your voucher/package. **THE CHARGE FOR REVALIDATION IS £25 ADMINISTRATION + APPROPRIATE AIR FIRST LTD MEMBERSHIP and ANY PRICE INCREASE OR SURCHARGE** and must be paid prior to original expiry date.

**AVAILABILITY AND BOOKING YOUR LESSON** All lessons must be booked in advance subject to availability. You should be aware that flying is highly weather dependent and allow for this when booking your lessons. **E-Vouchers, Standard 30 Minute Vouchers and Land Away Vouchers can only be flown Mondays to Friday – upgrades available.**

**RESTRICTIONS** include age (minimum 12 years), health, physical ability, weight & height. If you are aware of any health issues which may affect your safety and/or that of your instructor and aeroplane, you should seek the advice of your GP and disclose your condition to Air First. 15 Stone maximum weight and maximum height 6'0" for the C152. CFI & FI may make final decisions on suitability of weather.

**PHONE AIR FIRST BEFORE YOU LEAVE HOME** Please do not arrive at Blackbushe without first obtaining confirmation of the flight, on 01252 870999. You will need to bring 2 forms of identification for your first lesson which must include photographic (passport, driving licence) and a proof of address (telephone, water, gas, electricity). Please speak to Operations in advance of your booking if you are unable to supply appropriate identification. You are requested to arrive in good time for your lesson/s allowing 10 – 15 minutes for paperwork. However, for regular flying lessons you will be required to arrive a little earlier to allow for pre-flight checks in preparation for your due time slot. If you are late, please be aware that your lesson may be shortened or cancelled

**CHARGES ARE APPLIED TO AMENDMENTS AND CANCELLATIONS OF BOOKINGS** Please give as much notice as possible if you need to cancel or amend a booking. Non-Annual Members will be charged £5.00 per amendment to any booking in addition to the following; amendments made to bookings within 7 days of flight will incur a £25 admin charge. Amendments and cancellations made within 24 hours of flight incur an £80 cancellation charge. Amendments and cancellations must be made by phone to Air First Ltd on 01252 870999 between 09:00 and 17:00. Charges will be invoiced and deducted from funds on account or settled by customer within 7 days of invoice. Bookings will cease until invoice has been paid.

**CUSTOMERS AND SPECTATORS** We welcome spectators of all ages to our flying school. Customers and spectators are expected to adhere to the rules and regulations of both the airport and Air First. If a customer or spectator is deemed under the influence of drugs, alcohol or in breach of any other rules or regulations they will be asked to leave and will not be permitted on site – Any affected flight will be immediately cancelled and the voucher forfeited.

**SUSPENSION OF MEMBERSHIP** as per the Flying Order Book, Air First reserves the right to suspend a membership for reasons such as poor airmanship until remedial training has been received and the CFI sees fit to reinstate or terminate membership. Funds on account will not be refunded.

**STANDARD RATES, PACKAGES, BUNDLES AND VOUCHERS** Special Terms apply to most packages and bundles of hours, it is each member's responsibility to check and understand any special terms prior to purchase. Accounts must be in credit to book any flight and outstanding invoices cleared before leaving the premises. Please note that plans and packages are not exempt from rate increases or necessary surcharges.
